



Housing Support

8 quick facts:

- Formerly Group Residential Housing (GRH).
- Money to help eligible people pay housing-related expenses.
- People have to apply.
- Paid to eligible providers on behalf of eligible people.
- Providers have a job to do.
- Places have to be eligible too.
- Not just for single adults.
- People can work!

How Housing Support Works



Housing Support

- 100% state-funded income support to pay for housing expenses, and sometimes additional services
 - Always
 - Room and Board, up to \$934 per month (20,000 people)
 - Starting 7/1/2020
 - Sometimes
 - Supplemental Services, \$482.84, or higher if approved by legislature (5,800 people)

Housing Support Standards

- Provision of room and board (everyone who on Housing Support)
 - three nutritional meals a day
 - a bed, clothing storage, linen, bedding, laundry supplies
 - housekeeping
 - maintenance and operation of the building and grounds
- Provision of supplemental services (in addition to room and board for about 25% of recipients)
 - connect people with resources for identified needs
 - case notes
 - general oversight and supervision
 - arranging for medical and social services
 - assist with transportation
 - other if required by legislature

Applying for Housing Support

- People have to apply for Housing Support to get it
 - Combined Application Form (DHS-5223) OR Change Report Form (DHS-2402) if a person is open on a cash assistance program already, OR Online (applymn.org).
 - Date of application impacts program start date
 - Only page 1 of the CAF must be complete to "lock in" the application date (name, address and signature)
 - Interview is required (but doesn't need to be in-person)
 - Other documents needed
 - Income and asset verifications
 - Disability verifications
 - Interim Assistance Agreement required for anyone not already on SSI

Administering Housing Support

- People have to apply for other programs for which they appear to be eligible (like Social Security).
 - SOAR/SSI advocacy can help people.
 - Disability Hub 866-333-2466
 - "Good cause" exception

Maintaining Housing Support

- People need to report changes within 10 days.
 - Starting and stopping work, other income changes, move out, etc.
- Absences
 - 18 days at a time (depending on circumstances) up to 60 days per year
 - County tracking required.
 - County staff should contact DHS policy area with questions.

Housing Support

Three things have to be true:

- Eligible person
- Eligible provider
- Eligible place
- No change
- No change

Eligible Person

- Must have low income and assets
- Adults age 65 or older, or adults age 18 or older with a certified disability or disabling condition that prevents work to the level of self-support

Housing Support and Work

- New asset limit of \$10,000
 - SSI recipients still follow SSI rules
- New earned income calculation for non-SSI recipients
 - Disregard the first \$65, then keep half of the rest
- New earned income reporting requirements
 - Most people report earned income every six months and keep increases during that time.

Eligible Person

- Basis of eligibility = verified reason
 - Elderly 65 and up
 - Certified Disability (SSI, RSDI, SMRT)
 - Disabling Condition (some GA conditions)
 - Verified by qualified professional or county designee
 - Transition from Residential Treatment
 - Verified by residential behavioral health treatment staff

New Professional Statement of Need (PSN)

- New <u>Professional Statement of Need (PSN)</u>
 - New elements to streamline eligibility for programs and services.
 - Housing Support
 - Basic program eligibility for recipients with disabling conditions.
 - Supplemental Service Rate eligibility
 - New "Transition from Residential Treatment" basis
 - Housing Stabilization Services
 - New MA state-plan service to help people with disabilities find and keep housing.

Residential Behavioral Health Treatment

- Licensed residential crisis stabilization services
- Licensed Intensive Residential Treatment Services (IRTS)
- Licensed residential substance use disorder (SUD) treatment

Residential Behavioral Health Treatment

- Documented housing instability when leaving treatment (Professional Statement of Need)
- Connect to Housing Support provider
- Apply for Housing Support

Transition from Residential Treatment

- Eligibility: Up to 3
 benefit months OR when
 person leaves.
- First month could be partial.
- No income or assets
- Need to be "technically" eligible.
- No interview unless needed to verify something.

Longer Term or Permanent

Traditional Housing
Support in same location
if eligible.

Traditional Housing Support in different location if eligible.

Important to know:

- People will get connected to housing support providers from treatment in a variety of ways.
- Eligibility is based on residential treatment staff verification.
- No changes to Supplemental Service Rate (SSR) eligibility or availability.
- Housing Support providers must help people apply for ongoing Housing Support payments if needed.

HB101 Places – new tool

Real time openings for people looking for housing with supportive services:

- One location to see a variety of housing options
- People can filter their search based on their service
- Allows efficient connection to Housing Support providers with openings

For providers:

- Show openings and property details.
- Provide online description of housing and eligibility criteria.
- Reduce calls about vacancies.
- Create a variety of useful reports for business and funding needs.



Supportive housing

- Habitability inspection for each unit
- Long Term Homeless programs need these for Supplemental Service Rate:
 - LTH verification form
 - Referred by coordinated entry system
 - find local entry points on mn.hb101.org

Send to eligibility worker at application.

Housing Support Community Setting - SSI Income



Housing Support providers must ensure every recipient has:

- food preparation and service for three nutritional meals a day on site
- a bed
- clothing storage
- linens/bedding
- laundry supplies or service
- housekeeping
- lavatory supplies or service
- maintenance and operation of the building and grounds

MSA Housing Assistance Eligibility

- Eligible for MSA, and
- Housing costs >40% of gross monthly income, and
- Under age 65 at initial eligibility, and EITHER
 - Relocating from institution: hospital, nursing facility, regional treatment center, intermediate care facility, intensive residential treatment services OR
 - Transitioning from Housing Support OR
 - Eligible for Personal Care services, OR
 - Waiver recipient in their own home or apartment.

MSA Housing Assistance (after 7/1/2020)

\$783 SSI benefit \$81 MSA benefit

+\$392 MSA Housing Assistance

\$473 Total MSA benefit

\$1,256 Total monthly income

= 60% increase in income over SSI alone

Housing Stabilization Services Housing Support Program Impact

2017 legislation for MN to pursue MA housing services:

- Duplication with supplemental services estimated at 50% (not 100%), for people in community-based settings
- Reduction of supplemental service rates by 50% scheduled for July 2021, only for these categories:
 - Long-Term Homeless Supportive Housing
 - Metro Demo
 - Housing with Services Independent Living (not assisted living)
- Reduction not dependent on provider enrollment in MA services

Housing Stabilization Services Housing Support Program Impact

What should Housing Support providers do?

- Identify which Housing Stabilization Service is a good fit for your agency to provide
- Enroll to become a Housing Stabilization Services provider
- Use the time to develop processes before rates change
- Develop partnerships for assessments, person-centered plans, and billing
- Get technical assistance if needed
